### To: Owners and Operators of Sweepstakes and Fish Games Businesses in the Town of Walkertown

This is a public advisory sent as a courtesy to inform you that on or after September 30th, 2020, the Town of Walkertown will begin enforcing the ban on electronic sweepstakes machines, video gaming machines, and slot machines (including fish games and like devices), pursuant to N.C.G.S § 14-306.1A and § 14-306.4, and other provisions found in Chapter 14, Article 37 of the General Statutes. This announcement is being made after consulting with the Forsyth County District Attorney's Office, in efforts to appropriately and respectively enforce the laws involving sweepstakes establishments and similar operations that may be in violation of the law.

Generally, N.C.G.S §14-306.4 prohibits the operation of electronic machines and devices for purposes of conducting sweepstakes. Any person who violates this section is guilty of a Class 1 Misdemeanor for the first offense, and is guilty of a Class H Felony on the second offense, and is guilty of a Class G felony for a third or subsequent offense.

Generally, N.C.G.S §14-306.1A prohibits the operation of slot machines as defined in N.C.G.S 14-306. This statute defines a slot machine or other form of electrical, mechanical, or computer game as any machine which for the payment of money, is operated in such a way that the operator receives a cash payout of any kind, irrespective of whether the game requires skill or dexterity, including fish games and other like devices. Any person who violates this section is guilty of a Class 1 Misdemeanor for the first offense, is guilty of a Class H Felony on the second offense, and is guilty of a Class G felony for a third or subsequent offense. Furthermore pursuant to N.C.G.S. §14-309, any person violating the provisions of N.C.G.S §14-306.1A involving the operation of five or more machines prohibited by this section is guilty of a Class G Felony.

If you have any questions concerning what may constitute a violation of North Carolina law, please consult your attorney. The Town of Walkertown, Forsyth County Sheriff's Office and the Forsyth County District Attorney's Office are not able to offer legal advice to you. Any machine (including fish games and other like devices) that pays out in cash in any amount may be prohibited under North Carolina law.

Any machine that awards points or credits that are redeemable for cash in any amount may be prohibited under North Carolina law.

Any machine that accepts more than eight points or credits during a single round of play may be prohibited under North Carolina law.

Any machine that is operated in connection with a sweepstakes that uses an entertaining display may be prohibited under North Carolina law.

Any person who owns or is involved in the operation of prohibited machines may be subject to criminal penalties, including managers and employees.

If you or your employee is charged with a violation, any devices used to promote the criminal act mentioned above are subject to seizure until the matter is heard by the court and may be forfeited if you or your employee is found guilty.

The goal of the Town of Walkertown is to provide

advance notice of law enforcement action and to allow a reasonable amount of time for local owners and operators to comply with the law in the event they are not currently in compliance. A copy of this notice will also be posted in a local newspaper of general circulation to advise owners/operators not currently known to the Town of Walkertown.

If you have any additional questions concerning what may constitute a violation of this law, you are asked to consult with your attorney.
